

Understanding the Annual Performance Report (APR)


- The APR is completed each year to summarize performance on indicators using data from the past FFY (Federal Fiscal Year)
 - Federal Fiscal Years run from July 1 to June 30.
 - Federal Fiscal Years are named for the calendar year in which they start (i.e., FFY2021 covers July 1, 2021 through June 30, 2022.)
- The key indicators focus on:
 - Compliance with timelines in IDEA (i.e., timely IFSP development, timely services, and timely transition). Targets are 100%.
 - Results on important outcomes for children and families (e.g., services in natural environments, child outcomes, family outcomes). Targets are set by the state, with stakeholder input.

Indicator 1: Timely Services

Percent of infants and toddlers with Individual Family Service Plans (IFSPs) who receive the early intervention services on their IFSPs in a timely manner

Target = 100%



Percent of infants and toddlers with IFSPs who primarily receive their early intervention services in their home or community-based settings



Percent of infants and toddlers with IFSPs who demonstrate growth on their positive social-emotional skills (social relationships)





Target = 85%



Percent of infants and toddlers with IFSPs who demonstrate growth on their use of appropriate behaviors to meet their needs



Percent of infants and toddlers with IFSPs who exited at/near age expectations on their positive social-emotional skills (social relationships)



Percent of infants and toddlers with IFSPs who exited at/near age expectations on their acquisition and use of knowledge and skills (early language/communication)



Percent of infants and toddlers with IFSPs who exited at/near age expectations on their use of appropriate behaviors to meet their needs



Percent of families participating in Part C who report that early intervention services have helped the family know their rights



Percent of families participating in Part C who report that early intervention services have helped the family effectively communicate their children's needs



Percent of families participating in Part C who report that early intervention services have helped the family help their children develop and learn





State Total = 209





State Total = 1592



Percent of eligible infants and toddlers with IFSPs for whom an initial evaluation/assessment and initial IFSP meeting were conducted within the 45-day timeline



Indicator 8A: Transition Plan

Percent of toddlers with disabilities exiting Part C with a transition plan (steps and services on IFSP) developed at least 90 days before the toddler's third birthday



Indicator 8B: Transition Notification

COMPLIANCE

Percent of toddlers with disabilities exiting Part C for whom the SEA and LEA where the toddler resides was notified at least 90 days before the toddler's third birthday



Indicator 8C: Transition Conference

COMPLIANCE

Percent of toddlers with disabilities exiting Part C for whom a transition conference was conducted (invited parties) at least 90 days before the toddler's third birthday
