# Mississippi Trauma Care System

## Introduction

The goal of the Mississippi Trauma Care System is to deliver the *right* patient to the *right* hospital at the *right* time. Research shows that this approach decreases mortality. Trauma remains the leading cause of death for Mississippians age 1 to 44 and Mississippi ranks third in the nation for unintentional injury deaths.

Mississippi began development of a statewide trauma system in 1991. The Mississippi Legislature charged the Mississippi State Department of Health with the responsibility for oversight of trauma system development. Since that time the state has adopted a trauma care plan, established seven designated trauma regions, designated qualifying hospitals as trauma centers, maintains a trauma registry, and disbursed funding to trauma regions, trauma centers, and physicians.

The Mississippi Legislature passed House Bill 1405 during the 2007 Regular Session to revitalize and more fully fund the Mississippi Trauma Care System. Mississippi moved from a voluntary system with indigent reimbursement, to a mandatory system with block grant funding based on participation; the first trauma system of its type in the United States. As suggested by the Mississippi Trauma Care Task Force, this report on the Mississippi Trauma Care System will be submitted quarterly to the Mississippi State Board of Health.

# **Trauma Center Inspections**

There were no inspections during this period.

## **Trauma Center Designations**

Ocean Springs Hospital was re-designated as a Level III Trauma Center on May 16, 2010. This action was at the request of Ocean Springs Hospital, as approved by the Coastal Trauma Care Region, and recommended by the Department's Trauma Consultant.

The following hospitals were designated as Level IV Trauma Centers effective March 1, 2010:

- South Sunflower County Hospital, Indianola
- Alliance Health Care System, Holly Springs
- Tri-Lakes Medical Center, Batesville
- Crossgates River Oaks Hospital, Brandon
- Noxubee Medical Complex, Macon
- Riley Hospital, Meridian

- St. Dominic Memorial Hospital, Jackson

Currently, in the Mississippi Trauma Care System, there are: three (3) Level I Trauma Centers (UMMC, Jackson; Regional Medical Center, Memphis; University of South Alabama, Mobile); five (5) Level II Trauma Centers (North Mississippi Medical Center, Tupelo; Baptist Memorial Hospital-Golden Triangle, Columbus; Forrest General Hospital, Hattiesburg; MHG, Gulfport; Singing River Hospital, Pascagoula); ten (10) Level III Trauma Centers; sixty five (65) Level IV Trauma Centers, three (3) non-participating hospitals (Mississippi Baptist Medical Center, Jackson; Gilmore Memorial Hospital, Amory; Trace Regional Hospital; Houston), and three (3) applicant hospitals.

# Mississippi Trauma Advisory Committee (MTAC) Activities

The MTAC met on March 4, 2010. Numerous changes to regulations were reviewed and recommended to the State Board of Health for adoption. Major changes to regulations included:

- Change the Trauma Care Trust Fund distribution model to distribute 5% of the total to designated Burn Centers.
- Add review of Play or Pay assessment survey by the Trauma Care Regions.
- Align regulation, inspection, and Essential & Desirable (E&D) verbiage to match.
- Incorporate E&D chart into respective Trauma Center chapters.
- Amend process to change Trauma Center designations.

The proposed regulations were approved by the State Board of Health on April 14, 2010 and became effective on May 16, 2010.

Other issues addressed by MTAC included the re-establishment of the Functionality Sub-committee chaired by Dr. Rick Carlton, the proposal to initiate a public education/outreach program concerning the Trauma System, and a review of the MEMSIS/State Bridge/Trauma Registry program specifically concerning Electronic Patient Care Reports (E-PCR).

The next meeting of MTAC is scheduled for June 15, 2010 in the Cobb Auditorium.


#### Significant committee actions for the period:

#### Rules and Regulations Sub-committee

The Sub-committee is working on a major re-write of Chapter 14 of the Mississippi Trauma Care Systems Regulations that addresses Burn Care. The chapter will follow the format of the Trauma Center chapters to define the requirements for a hospital to be designated as a Burn Center in the Trauma Care System.






#### Trauma Data Age and Gender


The top 7 mechanisms of injury




#### Work related injuries



ATV injuries with Protective Devices/Equipment






MVA with and without restraints
