
About our flu activity reporting

MSDH relies upon selected sentinel health practitioners across the state to report the percentage of total patient visits consistent with an influenza-like illness (ILI: fever of 100°F or higher AND cough and/or sore throat). Also, providers are supplied with specimen collection kits. Samples are submitted to the Mississippi Public Health Laboratory for influenza PCR testing. Reports are used to estimate the state's ILI rate and the magnitude of the state's influenza activity. Reports represent only the distribution of flu in the state, not an actual count of all flu cases statewide. *Information is provisional only and may change depending on additional reporting from sentinel providers.*

State ILI Surveillance



During week **02** (01/06/19-01/12/19), the overall state ILI rate (**3.6%**) **decreased** from the previous week (**4.1%**), and was lower than this time last year (**10.9%**). | Figure






Overall, the percentage of reported ILI cases has been highest among those in the **0-4** and **5-24 years** of age groups. The percentage of ILI cases decreased in the **0-4 years** of

age group, but increased in the **5-24 years** and **25-49 years** of age groups during week **02**. The percentage of ILI cases in the two other age groups remained constant when compared to the previous week. | Figure 2

The 2018-19 state ILI rate was **above** the national and Region 4 baselines, but was below the Mississippi baseline, during week **02**. | Figure 3




Mississippi ILI Rates 2014-2018 | Figure 4



Syndromic ILI Surveillance

The Mississippi State Department of Health also collects influenza syndromic surveillance data through the CDC BioSense Platform. This data is comprised of chief complaints and diagnosis codes and is submitted electronically by participating hospitals and clinics throughout the state in near real-time. The BioSense data is an additional tool to monitor influenza activity in Mississippi.

Influenza Outbreaks

Outbreaks are reportable in Mississippi as a Class 1A event and must be reported by telephone within **24 hours** of first knowledge or suspicion to the Mississippi State Department of Health. 
Between week 40 (week ending October 6th) and week **02** (week ending January 12th), three outbreaks were reported to MSDH. MSDH investigates all reported outbreaks, and of the three reported outbreaks, complete information was available for two of them. One outbreak was due an influenza A virus, unknown subtype and the other was due to an influenza A (H3) virus.

The influenza outbreaks have occurred in the following counties: Marion, Smith and Tate.

Flu Testing Reports


Since week 40 (week ending October 6th), **27** laboratory confirmed influenza samples have been identified by the MSDH Public Health Laboratory. Six (22%) were identified as influenza A (H1), 20 (74%) were identified as influenza A, H3, and one (4%) was identified as an influenza B. | Figure 6




The influenza cases were identified from the following counties: Attala (2), Carroll (1), Copiah (2), Covington (1), Hancock (1), Harrison (5), Hinds (2), Leake (1), Marion (4), Neshoba (1), Rankin (3), Tate (1), and Winston (1). The county of residence for two of the cases was unknown.

National and Mississippi Pediatric Mortality Surveillance

Nationally, **three** influenza-associated pediatric deaths were reported to CDC during week **02**. Two deaths were associated with an influenza A(H1N1)pdm09 virus and occurred during weeks 52 and 2 (weeks ending December 29, 2018 and January 12, 2019, respectively). One death was associated with an influenza A virus for which no subtyping was performed and occurred during week 52. **Nineteen** influenza-associated pediatric deaths have been reported to CDC for the 2018-2019 season. | Figure 7






Of the **19** influenza-associated pediatric deaths reported nationally during the 2018-2019 season, 18 (95%) have been attributed to influenza A viruses and one (5%) to an influenza B virus. | **Figure 8**

Mississippi has had **one** influenza-associated


pediatric death reported during this influenza season.

National ILI Surveillance

During week **02**, the Mississippi (3.6%), national (3.1%), and Region 4 (2.8%) ILI rates decreased. While the MS ILI rate was below its baseline, the national and Region 4 ILI rates were both above their respective baselines. | Figure 9

Mississippi reported "Regional" for the influenza activity during week 02. | Table 3

Level of Flu Activity	Definition	
No Activity	Overall clinical activity remains low and there are no lab confirmed cases.	
Sporadic	Isolated cases of lab confirmed influenza in the state; ILI activity is not increased <u>OR</u> A lab-confirmed outbreak in a single institution in the state; ILI activity is not increased.	
Local	Increased ILI within a single region AND recent (within the past 3 weeks) laboratory evidence of influenza in that region. ILI activity in other regions is not increased <u>OR</u> two of more institutional outbreaks (ILI or lab confirmed) within a single region AND recent (within the past 3 weeks) lab confirmed influenza in that region. Other regions do not have increased ILI and virus activity is no greater than sporadic in those regions	
Regional	Increased ILI in at least 2 regions but fewer than half of the regions AND recent (within the past 3 weeks) lab confirmed influenza in the affected regions <u>OR</u> Institutional outbreaks (ILI or lab confirmed) in at least 2 regions but fewer than half of the regions AND recent lab confirmed influenza in the affected regions.	
Widespread	Increased ILI and/or institutional outbreaks (ILI or lab confirmed) in at least half of the regions AND recent (within the past 3 weeks) lab confirmed influenza in the state.


















