# Preface

## Preface

### **Overview**

This publication reflects data collected in the hospital licensure process. A historical accounting of the responsibility for this function began in 1946 when the Mississippi Commission on Hospital Care was legislatively authorized to license non-federal hospitals and prepare an annual report. In 1979 the legislature passed a bill to merge the responsibilities of the Commission on Hospital Care into the Mississippi Health Care Commission and in 1986 another bill was passed to merge the responsibilities into the Mississippi State Department of Health.

In 1984, for planning purposes, the Statewide Health Coordinating Council (SHCC) established seven Hospital Service Areas based on where patients sought hospital care. Effective July 8, 2009, the State Board of Health changed the seven Hospital Service Areas to nine. For ease in using the data presented in this report, some tables are presented by the planning/service areas.

All facilities which appear in this publication were licensed in calendar year (CY) 2022 based on fiscal year (FY) 2021 data. This Annual Report\* is based on 100 hospitals: 88 acute care, three psychiatric, 1 rehabilitation, 1 OB/GYN, and seven long-term acute care. Statistics were not available for seven facilities (-see Directory under Appendix E). The five federal hospitals in Mississippi have been excluded. Additionally, East Mississippi State Hospital, Mississippi State Hospital, North Mississippi State Hospital, Oak Circle Center, South Mississippi State Hospital, and Whitfield Medical/Surgical Hospital<sup>1</sup> have been excluded from all data except Table 2, Table 3, Appendices B through D (NOTE: The database/system may have included state-operated facilities in other tables which should have been excluded (-see caveats under tables herein)<sup>1</sup>).

### **Hospital Ownership and Certification**

Eighty-eight hospitals in Mississippi are classified as medical/surgical. These figures were based on the type of service that the hospitals provided to the majority of admissions. On the other hand, the number of acute care beds include seven long-term care hospitals, 88 acute care hospitals plus the one OB/GYN facility. The acute care facility, Whitfield Med/Surg should not have been included in the acute care statistics.<sup>1</sup> The following seven counties in Mississippi do not have a hospital: Amite, Benton, Carroll, Humphreys, Issaquena, Itawamba, and Tunica.

Ownership and control of hospitals and beds are shown in Tables 1-A through 1-D. In 2021 there were 10,374 licensed acute care beds (10,396 beds include Whitfield). This count would have excluded Whitfield Medical Surgical Hospital but includes Allegiance Specialty Hospital of Greenville, KPC Promise Hospital of Vicksburg, Ochsner Specialty Hospital, Regency Hospital of Meridian, Select Specialty Hospital – Belhaven, Select Specialty Hospital - Gulf Coast, Inc., and Select Specialty Hospital – Jackson.

Sixteen hospitals reported 760 licensed psychiatric beds. Seventy-one percent of the beds, 536, were located at 13 acute care hospitals (only). Nine hospitals reported 252 licensed chemical dependency beds. Ten hospitals reported 303 rehabilitation beds. Seventy-four percent, 223, were located at nine acute care facilities (-see notes under Tables 1-A through 1-C)<sup>1</sup>.

Table 2 provides the number of hospitals and the percentages of hospitals which are accredited by the Joint Commission on Accreditation of Healthcare Organization (JCAHO). It also shows the number of hospitals participating in Blue Cross, Medicare, and Medicaid. At this time, information is not provided for hospitals participating in DNV Healthcare.\* Over half of all the 106 hospitals participate in the above categories (-see Directory under Appendix E).

**Hospital Employees**

Table 3 displays hospital personnel. Mississippi hospitals employed 54,067 people during 2021, of which 74.7% were full-time employees and 25.3% were part-time employees.

**Services Utilization**

Map 1 and Table 4 are new entries in the publication. Map 1 shows each county in the State of Mississippi and what counties are included in each of the nine Hospital Service Areas. Table 4 provides a list of counties by each of the nine Hospital Service Areas within the State.

In Table 10, hospitals reported 69,799 inpatient surgeries and 155,664 outpatient surgeries. This count includes only surgeries performed at acute care hospitals. Also, this table shows that the majority of surgeries were performed in Service Area 5.

Table 11 presents outpatient emergency visits and clinic/other visits by Hospital Service Area. Service Area 5 reported both the most outpatient emergency visits and clinic/other visits.

Table 12 displays hospitals which reported 138 rural health clinics and 1,408,671 rural health clinic visits. It also shows rural health clinics and visits by hospital service area.

**Bed, Name Changes and Closures**

Changes in the number of licensed beds and facility names are shown on page v within this document. The following hospitals closed: Greenwood AGM Specialty Hospital-LeFlore County, 40-Bed LTACH (8/31/2017) and Regency Hospital of Hattiesburg-Forrest County, 33-Bed LTACH (7/18/2018).

## ***Utilization***

Table 13 shows hospitals and beds by bed size groupings. Occupancy rates are also shown by bed size. Under the acute care bed capacity category, it shows that hospitals with the highest number of hospital beds fall under the following ranges: 25-49 beds, 50- 99 beds, and 100-199 beds. Of the 16 hospitals reporting psychiatric beds, three were licensed as psychiatric hospitals. Two hundred fifty-two chemical dependency beds were reported at nine hospitals. Ten hospitals reported 303 rehabilitation beds.

Table 14-A gives average lengths of stay (ALOS), average daily census (ADC), percentages of occupancy for each hospital by licensed acute care bed capacity and state totals. Psychiatric data can be found in Table 14-B, chemical dependency data in Table 14-C, and rehabilitation data in Table 14-D.

A comparison of licensed beds and beds set up and staffed is shown in Tables 15-A through 15-D. Of the 10,374 licensed acute beds, 8,696 beds were set up and staffed. Seven hundred thirty one of the 760 licensed psychiatric beds were set up and staffed. One hundred fourteen of the 252 licensed chemical dependency beds were set up and staffed.

Statistics were not available for Table 16 showing the number of swing beds, average length of stay and average daily census by facility, the destination of discharged swing bed patients, number referred to home health, and number of acute care beds designated as swing beds by service area. Table 17 would have provided swing bed statistics pertaining to discharge location, referrals, and admissions to the hospitals; however, data/figures were not available for this table. Also, data/figures were not available for Table 18 displaying swing bed utilization in 2021 by hospital service area.

## ***Hospital Use Statistics***

Table 19 shows the population of each service area in comparison with its licensed bed capacity. Service areas are maintaining a relatively close correlation between the percentage of population and percentage of licensed hospital beds. Service Area 5, including the city of Jackson and Hinds County, has the largest population at 25.56% and the most beds at 33.8%. Licensed beds by type are also shown by hospital service area.

Table 20-A provides information on acute hospital beds, admissions, discharges, deaths and inpatient days by service area and county. Psychiatric, chemical dependency and rehabilitation beds located in acute care facilities are included in Table 20-B along with those facilities that are licensed as psychiatric, or rehabilitation facilities. As previously mentioned, there are 10,374 licensed acute care hospital beds in Mississippi, 760 psychiatric beds, 252 chemical dependency beds, and 303 rehabilitation beds.

A comparison of utilization statistics for 2012, 2017 and 2022 is shown in Table 21.

Table 22 deals with newborn statistics. Once again, Service Area 5 leads in every category, as does Hinds County. Table 23 compares the newborn statistics of 2021 with those of 2016 and 2011. There was a -12.85% percent change (decrease) in bassinets and a -16.08 percent change (decrease) in obstetrical beds set up and staffed. Deliveries saw a -15.29 percent change (decrease) from 2011. There were 25.06 percent less fetal deaths reported in 2021 than in 2011.

Table 24 displays discharges, discharge days, admissions, and inpatient days by service area for DP SNF, geriatric psychiatric, patients 65 and older, Medicare and Medicaid.

Table 25 shows beds set up, discharges, discharge days and inpatient days for the state's hospitals. Data/figures reported by specialty hospitals are also included. Data/figures are broken down into acute care, intensive care, other care, and long-term care.

### ***Obstetrical Utilization***

2021 obstetrical utilization is shown in Appendix A.

In Appendices B and C, hospitals and their licensed category are listed in alphabetical order by county and then, by facility. The hospital directory is located in Appendix E. The licensed bed capacity is reported as of January 1, 2022 whereas the rest of the report is as of the end of the reporting period, usually September 30, 2021 (October 1<sup>st</sup> – September 30<sup>th</sup> of each year).

### ***State Owned Facilities***

Data relating to state owned facilities operated by the Mississippi Department of Mental Health - Behavioral Health Program are under Appendix D.

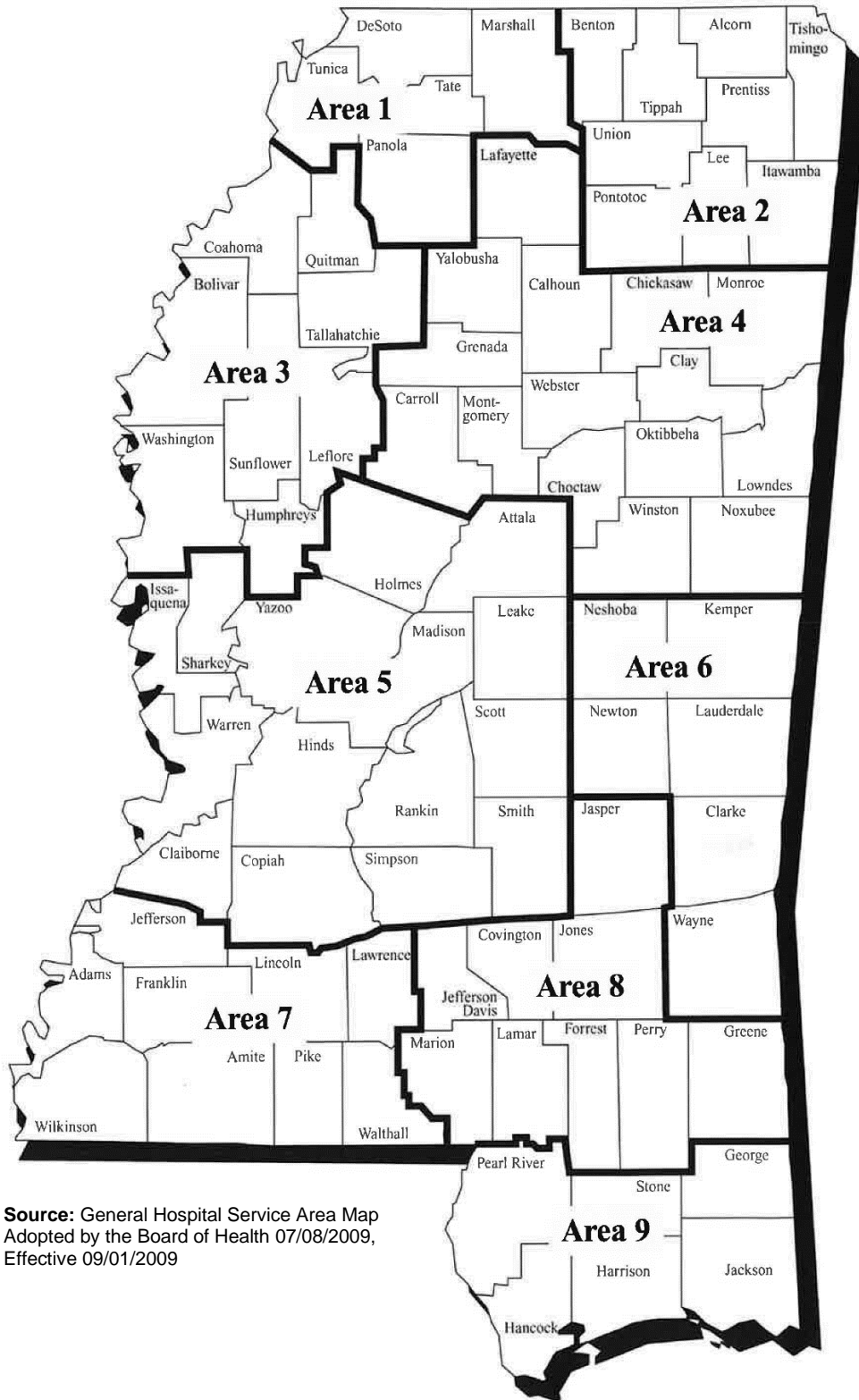
