1.	Establish quorum	A quorum was established with both a SLP and AUD member present with the five (5) council members present.
2.	Approval of January 17, 2025 and May 9, 2025 minutes	The minutes of both meetings, January 17, 2025 and May 9, 2025, were approved. January 17, 2025: motion: Ms. Burklow, 2 nd : Ms. Alston May 9, 2025: motion: Dr. House, 2 nd : Dr. Turner
3.	PRAXIS scores	From the May advisory council meeting, Ms. Wang stated that Dr. Turner informed the Council that the passing PRAXIS score for both SLP and AUD is 162. A motion was made by Ms. Alston to approve the minimum passing PRAXIS score, and 2 nd by Ms. Burklow. The motion was approved.
4.	Hearing Aid Return Period	Dr. Turner stated that MSHA did draft verbiage on the return period for hearing aids, and are currently reviewing and providing feedback. MSHA will send to MSDH once approved.
5.	ASLP-IC Update	A special commission meeting for ASLP-IC was held on June 30, 2025, along with two (2) onboarding meetings for Compact Connect. The special commission meeting was for a proposed FY26 budget, and to approve proposed rules for fees and the criminal background check requirement. The compact fee will be set at \$50.00 in addition to each state's privilege fee, plus processing fees. There will be an annual commission meeting on September 20, 2025, which both Ms. Wang and Ms. Saleem will be attending after the NCSB Conference.
