1.	Approval of June 3, 2024 minutes	A motion was made by Mr. Franks and seconded by Ms. Barham to approve the minutes of the June 3, 2024 minutes. The motion passed.
2.	Renewal Update	Mrs. Robbins informed the Council that there are 402 active ATs, with 4 late renewals, and there are 40 closed ATs who did not renew.
3.	Complaint Report	<p>Ms. Wang updated the Council that a cease and desist was sent to an individual who was seen wearing a name badge with "MSAT, ATC" at the Toyota Family Health Center in Blue Springs. The health center also received a copy of the cease and desist, and the BOC was also notified of the complaint. Mr. Jason Graham from the BOC informed the Department that they closed the case.</p> <p>Ms. Wang informed the Council received a complaint regarding the individual who is a first aid responder (that previous complaints have been received from Jackson State University) now at Canton High School. A letter was sent to the principal at CHS and superintendent of Canton Public School District. The individual reached out to the Department to inform that he is only providing services as a first aid responder, and that he informed the school district and high school at hiring that he is not an AT. CHS has him listed as a First Aid Responder/AT. The Department notified him to have the school system list him as First Aid Responder only.</p> <p>Mr. Richey asked if a complaint has been received on an individual in Cleveland, Ms. Wang informed the Council none has been received. Mr. Richey informed he would reach out to the individual who was supposed to submit the complaint.</p>


