SENATE BILL NO. 2513

- AN ACT TO AMEND SECTION 69-7-607, MISSISSIPPI CODE OF 1972, TO REQUIRE FISH PRODUCTS AS DEFINED IN THE CATFISH MARKETING LAW TO BE SUBJECT TO SAME LABELING REQUIREMENTS AS CATFISH PRODUCTS; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1**. Section 69-7-607, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 69-7-607. (1) Notice of country of origin.
- 9 (a) General requirements:
- 10 (i) All retailers of catfish and fish products, as
- 11 defined in Section 69-7-605, shall inform consumers, at the final
- 12 point of sale of the catfish or fish to the consumers, of the
- 13 country of origin of the catfish or fish;
- 14 (ii) United States country of origin. A retailer
- 15 of catfish or fish products may designate the catfish or fish as
- 16 having a United States country of origin only if:
- 1. In case of "Farm-raised Catfish or
- 18 Farm-raised Fish," it is hatched, raised, harvested and processed
- 19 in the United States;

20 2. In case of "River or Lake Catfis	h <u>or River</u>

- 21 or Lake Fish," it is:
- 22 a. Harvested in waters of the United
- 23 States, a territory of the United States or a state, including the
- 24 waters thereof; and
- b. Processed in the United States, a
- 26 territory of the United States or a state, including the waters
- 27 thereof;
- 28 (iii) Farm-raised and River or Lake Catfish,
- 29 Farm-raised and River or Lake Fish. The notice of country of
- 30 origin for "Farm-raised Catfish," or "Farm-raised Fish," and
- 31 "River or Lake Catfish" or "River or Lake Fish" shall distinguish
- 32 between "Farm-raised Catfish" and "River or Lake Catfish * * *" or
- 33 "Farm-raised Fish" and "River or Lake Fish."
- 34 (b) Method of notification.
- 35 (i) Retailers.
- 36 1. The information required by paragraph (a)
- 37 of subsection (1) of this section may be provided to consumers by
- 38 means of a label, stamp, mark, placard or other clear and visible
- 39 sign on the catfish or fish or on the package, display, holding
- 40 unit or bin containing the catfish or fish at the final point of
- 41 sale to consumers.
- 42 2. If the catfish or fish is already
- 43 individually labeled for retail sale regarding country of origin,

- 44 the retailer shall not be required to provide any additional
- 45 information to comply with this section.
- 46 (ii) Food service establishments. The information
- 47 required by paragraph (a) of subsection (1) of this section shall
- 48 be provided to the consumer on the menu of the food service
- 49 establishment. For foreign or imported catfish or fish, the
- 50 information shall be adjacent to the item on the menu and printed
- 51 in the same font style and size as the item. If the food service
- 52 establishment offers for sale only catfish or fish having a United
- 53 States country of origin, then the food service establishment may
- 54 generally disclose this in a prominent location in the food
- 55 service establishment in lieu of disclosure on the menu. The
- 56 signage disclosing the sale of catfish or fish having a United
- 57 States country of origin, that is to be placed in a prominent
- 58 location in the food service establishment, shall be
- 59 approved * * * by the Mississippi Department of Agriculture and
- 60 Commerce, which shall be held harmless in a cause of action for a
- 61 retail or food service establishment's failure to disclose or
- 62 fraudulent disclosure. Any liability arising from failure to
- 63 disclose country of origin shall remain with the wholesaler and
- 64 the retail or food service establishment.
- 65 (c) The commissioner may require that any person that
- 66 prepares, stores, handles or distributes catfish or fish for
- 67 retail sale maintain a verifiable record-keeping audit trail that

- 68 permits the commissioner to verify compliance with this law and
- 69 any regulations promulgated hereunder.
- 70 (d) Any distributor or wholesaler engaged in the
- 71 business of supplying catfish or fish to a retailer or food
- 72 service establishment shall provide information to the retailer or
- 73 food service establishment indicating the country of origin of the
- 74 catfish or fish. The information shall include certification of
- 75 origin through a state or federal agency that regulates the
- 76 processing of catfish or fish or through a federal agency that
- 77 verifies that catfish or fish and/or other products produced in
- 78 countries other than the United States meets similar sanitation
- 79 requirements.
- 80 (2) Any advertising as to any catfish or fish product shall
- 81 state the information required in paragraph (a) of subsection (1)
- 82 of this section.
- 83 (3) The term "catfish" shall not be used as a common name or
- 84 in the label name of fish product except as provided in this
- 85 section.
- 86 (4) The commissioner shall have authority to enter the
- 87 premises of any wholesaler, processor, distributor, retailer or
- 88 any other person selling catfish or fish products in order to
- 89 determine compliance with this article.
- 90 (5) This section shall not apply to catfish or fish products
- 91 exported out of the United States.

- 92 **SECTION 2.** This act shall take effect and be in force from
- 93 and after July 1, 2013.
