Introduction

The goal of the Mississippi Trauma Care System is to deliver the *right* patient to the *right* hospital at the *right* time. Research shows that this approach decreases mortality. Trauma remains the leading cause of death for Mississippians age 1 to 44 and Mississippi ranks third in the nation for unintentional injury deaths.

Mississippi began development of a statewide trauma system in 1991. The Mississippi Legislature charged the Mississippi State Department of Health with the responsibility for oversight of trauma system development. Since that time the state has adopted a trauma care plan, established seven designated trauma regions, designated qualifying hospitals as trauma centers, maintains a trauma registry, and disbursed funding to trauma regions, trauma centers, and physicians.

The Mississippi Legislature passed House Bill 1405 during the 2007 Regular Session to revitalize and more fully fund the Mississippi Trauma Care System. Mississippi moved from a voluntary system with indigent reimbursement, to a mandatory system with block grant funding based on participation; the first trauma system of its type in the United States. As suggested by the Mississippi Trauma Care Task Force, this report on the Mississippi Trauma Care System will be submitted quarterly to the Mississippi State Board of Health.

 Three (3) Level I Trauma Centers (UMMC, Jackson; Regional Medical Center, Memphis; University of South Alabama, Mobile);

- Five (5) Level II Trauma Centers (North Mississippi Medical Center, Tupelo; Baptist Memorial Hospital-Golden Triangle, Columbus; Forrest General Hospital, Hattiesburg; Memorial Hospital of Gulfport, Gulfport; Singing River Hospital, Pascagoula);
- Twelve (12) Level III Trauma Centers; and
- Sixty (63) Level IV Trauma Centers.

Mississippi Trauma Advisory Committee (MTAC) Activities:

MTAC held its last quarterly meeting of CY2011 on December 1, 2011 in the Cobb Auditorium:

- The Rules and Regulations sub-committee reviewed four rules for changes:
 - Rule 1.2.8 Trauma Center Inspections authorizing the State Health Officer to extend Trauma Center designations for up to one (1) year.
 - Rule 5.3.1 Level IV Emergency Departments allowing the Rural Trauma Course (RTC) in lieu of Advanced Trauma Life Support (ATLS) for Level IV Emergency Department (ED) physicians
 - Rule 6.1.9 Tertiary Pediatric Trauma Centers requiring physician response to match Level I adult Trauma Center standards
 - Rule 6.2.9 Secondary Pediatric Trauma Centers requiring physician response to match Level III adult Trauma Center standards
- The sub-committee also addressed allowing Advanced Trauma Care for Nurses (ATCN) to be recognized as an approved Trauma Nurse course in addition to Trauma Nurse Core Curriculum (TNCC).
- The sub-committee also discussed the formation of a task force to rewrite the Essentials & Desirables (E&D) charts for the different levels of Trauma Centers, Pediatric Trauma Centers, and the Burn Center.
- The Functionality sub-committee recommended a task force to research the process of implementing a state-wide medical communications system.


MTAC held its first quarterly meeting of CY2012 on January 25, 2012 in the Cobb Auditorium:


O MTAC will recommend to the Emergency Medical Services Advisory Council (EMSAC) that a committee be formed to research and recommend a medical communications system that will service EMS, Trauma, STEMI, Stroke, and any other systems of care that may be formed. Responsibility for Medical Control of EMS agencies will remain with the Medical Directors' Training and Quality Assurance (MDTQA) committee.

- Rules & Regulations/Functionality Sub-committees will research and recommend changes to the Play or Pay schedule, as it has not been reviewed since 2008. Additionally, Mississippi Hospital Association (MHA) will be contacted to assist with this project.
- O Jonathan Wilson, ED Manager at the University of Mississippi Medical Center and EMSAC/MTAC member, was honored by the Emergency Nurses' Association (ENA) as a Recipient of Distinguished Recognition. Mr. Wilson was one of the finalists for ENA's ED Nurse Leader of the Year award.









The top 7 mechanisms of injury




Work related injuries




ATV injuries with Protective Devices/Equipment

Performance Improvement (PI) Program:


The State Trauma PI Committee has been restructured into the State PI Committee. Mr. Bill Oliver will be the State PI Coordinator and co-chair of the individual PI committees: Trauma, STEMI, and eventually, Stroke. Dr. John Porter has been selected as the chairman of the Trauma Committee, replacing Dr. Frank Ehrlich.

The committee had met on January 13, 2012. The region representatives presented summaries of the PI activities conducted by their region and any issues associated with PI data and/or review. The following changes have been made to the Trauma PI process based on the last year's efforts:

- Meetings will be bi-monthly instead of semi-annually.
- The range of cases will be based on the state average/mean + one (1) standard deviation.
- The Trauma Outcomes Performance Improvement Course (TOPIC) will be scheduled for all of the Trauma PI Committee members. The Department will purchase the texts for committee members attending the course.

An analysis of Trauma Activation/Field Triage Criteria was accomplished by UMMC. The staff reviewed 500+ cases starting 3 months before field activation became effective through 3 months after the implementation date. A number of factors were found and will be presented to the Rules & Regulations/ Functionality Sub-committees to consider a modification of the current criteria.
