#### **MINUTES**

## Welcome/Introductions (S. Miller)

S. Miller, SICC Chair, opened the meeting at 9:15am. S. Miller welcomed all SICC members, appointees and attendees.

## Review and Approval of Minutes (S. Miller)

The minutes from the April21, 2017 meeting were reviewed. L. Shivers made a motion, seconded by S. Davis, to vote to approve the minutes.

## **Business** (S. Miller)

- Appointments and orientation
  - S. Callender and V. Davis informed council of meeting with Governor on August 3, 2017 at 3:30pm, location TBD.
    - S. Miller asked if there was anything that the committee needed to prepare before the meeting with the Governor.
    - S. Callender replied, nothing that she is aware of this time.
    - L. Shivers recommended that a small presentation be prepared for the meeting with the Governor, outlining the purpose of the SICC.
    - S. Miller thanked everyone for being able to meet with the Governor on short notice and for their dedication to the SICC.
    - R. Blakeney stressed the importance of getting on the Legislative agenda for the upcoming session to ensure buy in for SICC supported initiatives.
- Mission and Bylaws Revision Committee report (L. Shivers)
  - The committee reported they have made changes to the Bylaws and reviewed with the group.
  - Changes noted in Bylaws:
    - Distinction in terminology for consistency;
    - Alignment of functions and practices;
    - Change in name of DHS to CPS
  - S. Miller and L. Shivers stressed the importance of recruiting new chairs and co-chairs for the SICC committee both agreed to be peer mentors for selected persons.

## <u>Program Updates</u> (M. Richardson, V. Davis (EI) & D. Whitker (EHDI)) – see presentation for details.

- State Determinations
  - M. Richardson explained each indicator and the determination for each State EI Program. She further explained how District performance contributed to the overall State-identified Measurable Result (SiMR) [Target 64%].
  - S. Callender noted the program had experienced technical challenges with reporting Part C transition data to the State Dept. of Education. C. Taylor reported the challenges may be related to MDE transitioning to a new data system. S. Callender recommended revising/updating communication plans developed by local EI Programs and LEAs in 2015 to improve partnerships to support Part C to B transition.
  - Lynnette Harper introduced as new El training Facilitator.

## Monitoring Updates

- Public Health Districts VII, III, and IV were monitored FFY 2016. Report issued for Dist.
   VII, reports are pending for Districts III, IV due to delays as a result of agency reorganization.
- District Monitoring for FFY 2017 will be done by regions due to agency reorganization with Region 3 to receive onsite and Regions 1 & 2 to do self-assessment during same time frame. Each district/region provided a copy of the monitoring tool.

#### EHDI Updates

- EHDI is funded by grants issued through CDC and HRSA
- Moment of silence to acknowledge Sheila Cargile who passed away and was extremely instrumental in the establishment of MS Hands & Voices Chapter.
- New MS Hands & Voices Chapter leaders; Julie Seawright and Stacy Dezutter.
- o D. Whitker provided and overview of Guide By Your Side (GBYS-MS).
- Part of the HRSA Grant is to establish Learning Communities which are to be organized by M. Chunn
- o EHDI will begin reissuance of "Report Card"
- EHDI has received final approval on new forms for more effective reporting of data.
- o NATUS system getting closer to finalization.
